Background Context

This is the twelfth quarterly mandate maintenance report produced by the Ngātiwai Trust Board (NTB) for the Office of Treaty Settlements (OTS) following the Crown's recognition of the NTB Deed of Mandate (DoM) on 21 October 2015.

The purpose of this report is to document the work undertaken by the NTB to maintain its mandate and in particular to demonstrate its ongoing commitment to continually improve its communications and engagement with Ngātiwai members so as to keep members properly informed about the negotiations and Treaty settlement journey.

Mandate Maintenance requirements

Section 55 of the Deed of Mandate states:

"The NTB will ensure that Ngātiwai members are kept regularly informed and updated on negotiations progress through:

- monthly newsletters/e-panui and website with regular updates
- hui or wananga on particular topics will be held regularly through the year
- the AGM or a Special General Meeting where the need arises (i.e. to present an iDoS and a proposal for a PSGE to the claimants community for approval and ratification)
- Negotiators will also be required to report to Te lwi o Ngātiwai on negotiations as required by the NTB (see page 22)
- monthly Board meeting summaries to be released following each meeting providing regular updates on matters under discussion by the Board and
- Three additional hui-a-iwi (in addition to the AGM) in total providing quarterly opportunities for engagement and discussion.

The focus will be on the progress of negotiations."

Section 56 of the Deed of Mandate states:

"The NTB will provide regular three monthly reports to OTS to maintain the mandate. It will include information about:

- communications with Ngātiwai (i.e.newsletters/e-panui, hui or wananga, website and Facebook updates),
- any AGMs or SGM held within the reporting period, and
- any other points of interest related to the progress of negotiations."

While it is acknowledged that the OTS have a standard form for mandate maintenance reports this report covers those requirements and builds on the previous commitments made by the Board in its Engagement and Communications Plan dated 13 December 2014. For this reason it includes a brief summary of progress made towards achieving specific objectives established in December 2014.

Issues Arising 1 February to 31 April 2019

Terms of Negotiation and The Ngātiwai Mandate Report

- 1. Completion of Terms of Negotiations (ToN) were paused pending the outcome of the Ngātiwai Mandate Inquiry by the Waitangi Tribunal and remain paused.
- The Board continued work to develop a DRAFT mandate mediation proposal based on the recommendations from the Waitangi Tribunal and to seek a meeting with the Minister to discuss the DRAFT. A meeting took place with Minister Little on 2 February 2019 at Waitangi.
- 3. On 26 February 2019, the Minister wrote to the Board requesting that it submit its proposals even if it is only in DRAFT so that officials can begin assessing it. On 6 March 2019, the Board submitted its proposal and budget to the Minister and copied it to the hapū who sought the urgent inquiry to alert them to work in progress.
- 4. The third wananga-a-iwi in the series (which had been postponed in 2018) was reorganised into two discrete hui. The first of which was a kaumātua wananga held on 29 March 2019 at Ngunguru Marae. The second of which was a hui-a-iwi held on 30 March 2019 also at Ngunguru Marae to which the kaumātua presented the recommendations from their wananga. Of note the Kaumātua recommended that:
 - a. a hui-a-iwi be held for whanau to express their aspirations for the future of Ngatiwai;
 - b. a completely new constitution be developed and that the role of the kaumātua "to maintain the cultural and spiritual integrity" of the iwi be reflected accordingly; and
 - c. work-streams are being formed based on key interests/knowledge of kaumātua (i.e. Environment, Treaty, Education, Health, Kapa Haka, Music, Te Reo etc.)
- 5. At the hui-a-iwi the Treaty Claims Committee provided an update on the work that it had been undertaking to develop a mediation plan. It was noted that:
 - a DRAFT mediation proposal and budget had been submitted to the Crown and the Board were awaiting a response before mediation discussions could take place with the affected hapū; and
 - b. that the Board had requested that funding also be made directly available to the affected hapū so that they could take part in any agreed mediation process with the Board on an equal footing.
- On 11 April 2019, the Minister confirmed that officials are currently assessing the Boards DRAFT proposal and will be in contact if they have any questions. Once the Minister has received their assessment he will provide a comprehensive response regarding the proposal and funding.

Overlapping Claims with other lwi / Large Natural Groupings

- 7. On 5 March 2019, the Board requested confirmation from Minister Little that the Hauraki Settlements will be put on pause pending the outcome of the Waitangi Tribunal's urgent inquiry into the Hauraki overlapping claims to be held in Wellington from 8 to 12 April 2019.
- 8. On 11 March 2019, the Board requested that the Minister pause harbour negotiations as it considered such discussions an extension of the Hauraki overlapping claims matters before the Waitangi Tribunal.
- 9. On 11 April 2019, the Minister confirmed that:
 - a. the Crown does not intend to introduce Hauraki settlement legislation while the Tribunal inquiry into the six claims granted urgency is ongoing.

- harbour discussions are preliminary only and negotiations have not yet begun.
 No negotiations regarding the Hauraki Gulf will commence until matters such as the structure of negotiations and who should be involved in negotiations are confirmed.
- 10. The Waitangi Tribunal held hearings concerning the Hauraki overlapping claims at Waiwhetu Marae in Wellington from 8 to 12 April 2019. The Board sent a delegation of kaumātua, Trustees, staff and hau kainga from within the disputed area to present its case at these hearings.

Marine and Coastal Area Act (MACA)

11. The Waitangi Tribunal held stage one hearings concerning the MACA from 25 to 29 March 2019. Stage one concerned the procedural arrangements and resources provided under the MACA and whether or not these procedures and arrangements breached the Treaty of Waitangi. The Board sent a delegation to present its case at these hearings.

Communications and Engagement with Ngātiwai Whanui

Open Door Policy and Face to Face Engagement Hui

1. Progress on this objective has been maintained.

Monthly Board Updates and Newsletters

2. Monthly Board meeting summaries are now regularly posted to our website and Facebook pages following each Board meeting. They are also included in our newsletter which is then sent to our Kaumātua by post along with a hard copy of the newsletter.

Trust Deed Review

3. The review group has suffered again from loss of membership. See kaumātua recommendations (above).

Wananga Planning for PSGE

4. This topic is likely to be discussed as part of the mediation plan (see above).

Quarterly Hui-a-lwi

5. A hui-a-iwi took place on 30 March 2019 at Ngunguru Marae. This was preceded by a Ngatiwai Kaumatua wananga the evening before.

Finalise the Strategic Communications Plan

6. The plan has been completed and is available on our website for public view.

Review, refine and maintain the current database

- 7. Regular address updates and new registrations continue to be promoted and received.
- 8. The total number of registered members as at 30 April 2019 is 8143 (including 53 pending registrations). This is an increase of 80 registered members within the quarter.
- 9. The registered members who are recorded as without a known postal address or are recorded as Gone-No-Address (GNA) is 933 or 11%.
