

## NGATIWAI TREATY SETTLEMENT NEGOTIATIONS

- The Boards mandate for negotiations remains paused while the Treaty Claims Committee seek to meet with claimants to establish a mediation process
- A hui was held with Patuharakeke at Takahiwai Marae in April they are seeking to withdraw from both the Ngatiwai and Ngati Whātua mandates and wish to seek return of their lands via the Waitangi Tribunals process Northland Regional Plan Appeal
- The Whangaruru claimants were supported to meet together to provide feedback on the Boards mediation proposal late last year. Feedback received after hui held over Christmas and in April is that relationships have become strained and little progress has been made. Despite this there is a desire to host public huiTautoko for our hapū



### **OVERLAPPING CLAIMS**

 The Hauraki Settlements were paused following the outcome of the Hauraki Overlapping Claims Inquiry held in Wellington in April 2019

 The Treaty Claims Committed met with Marutūāhu groups in April to attempt to agree on a process for resolving overlapping claim consistent with tikanga. While relationships have improved little progress was made on any agreement

 The Treaty Claims Committee held a further hui with Te Rūnanga o Ngati Whātua in March and expressed concern that the Crown has not retained adequate capacity to provide redress for Ngatiwai within our rohe when our negotiations commence



# MARINE AND COASTAL AREA ACT INQUIRY (MACA)

- The High Court released its Whakatohea decision about Maori customary rights in the Takutai Moana in May. The decision was surprisingly good. However, appeals have now been lodged against it
- Work continues on compiling our evidence and engaging with overlapping MACA applicants to attempt to share information and coordinate efforts when the High Court hearings get underway in Whangarei
- The stage 2 MACA hearings for claimant evidence concluded in May. We
  organised for a technical expert witness to present evidence that shows that any
  right able to be won under the Act will be squashed by the RMA resource
  consenting regime



# NGATIWAI TRUST BOARD POSITION ON MACA

The Ngātiwai Trust Board has passed a resolution that states:

"That the Board formally agree to any rights able to be won under the MACA Act, via the Boards applications, will be held at the local whanau or hapu level and not with the Board or any Trustees."



## NGĀTIWAI TRUST BOARD POSITION ON MACA

The Board also states:

"The Board has taken the position that is supports all Ngatiwai MACA applicants in-principle and there may well be a form of shared-exclusivity in some areas. To avoid a situation arising where the Board is seen to be favouring one whānau or hāpu over another the Board will need to take a supportive but neutral role on these matters which are more appropriately worked through in accordance with tikanga at the local level."
