Background Context

This is the seventeenth quarterly mandate maintenance report produced by the Ngatiwai Trust Board (NTB) for the Crown (Te Arawhiti) following the Crown's recognition of the NTB Deed of Mandate (DoM) on 21 October 2015.

The purpose of this report is to document the work undertaken by the NTB to maintain its mandate and in particular to demonstrate its ongoing commitment to continually improve its communications and engagement with Ngātiwai members so as to keep members properly informed about the negotiations and Treaty settlement journey.

Mandate Maintenance requirements

Section 55 of the Deed of Mandate states:

"The NTB will ensure that Ngātiwai members are kept regularly informed and updated on negotiations progress through:

- monthly newsletters/e-panui and website with regular updates
- hui or wananga on particular topics will be held regularly through the year
- the AGM or a Special General Meeting where the need arises (i.e. to present an iDoS and a proposal for a PSGE to the claimants community for approval and ratification)
- Negotiators will also be required to report to Te lwi o Ngātiwai on negotiations as required by the NTB (see page 22)
- monthly Board meeting summaries to be released following each meeting providing regular updates on matters under discussion by the Board and
- Three additional hui-a-iwi (in addition to the AGM) in total providing quarterly opportunities for engagement and discussion.

The focus will be on the progress of negotiations."

Section 56 of the Deed of Mandate states:

"The NTB will provide regular three monthly reports to OTS to maintain the mandate. It will include information about:

- communications with Ngātiwai (i.e.newsletters/e-panui, hui or wananga, website and Facebook updates),
- any AGMs or SGM held within the reporting period, and
- any other points of interest related to the progress of negotiations."

While it is acknowledged that the OTS have a standard form for mandate maintenance reports this report covers those requirements and builds on the previous commitments made by the Board in its Engagement and Communications Plan dated 13 December 2014. For this reason it includes a brief summary of progress made towards achieving specific objectives established in December 2014.

Issues Arising

Terms of Negotiation

 Completion of Terms of Negotiations (ToN) were paused pending the outcome of the Ngātiwai Mandate Inquiry by the Waitangi Tribunal and remain paused until mandate mediation is complete.

Mandate Mediation

Mediation Proposals and Funding

- 2. On 12 November 2019, the Board responded to legal counsel for Te Whakapiko hapū of Ngati Manaia in relation to their letter of 25 October 2019 setting out their approach and funding proposal for mediation. In response the Board noted that:
 - a. the "claimant definition" was identified by the Waitangi Tribunal in its report on the Ngatiwai Mandate Inquiry as one of the "matters to be resolved" including with the help of independent research,
 - b. there are further "matters to be resolved" that may need to be considered,
 - c. a revised research proposal for a scoping report had been developed following feedback from the Crown and now seeking feedback from Te Whakapiko,
 - d. the Boards funding was subject to providing proof of costs, reporting and milestones,
 - e. the Boards planning approach to the mediation had been to faithfully follow the Tribunals recommendations.
 - f. the current membership of the Treaty Claims Committee,
 - g. in the event that mediation progresses well a recommendation that the Te Whakapiko budget allow for up to 5 mediation hui and associated costs.
- 3. During November 2019, the Crown advised that it had received enquiries or funding proposals from those groups to be included in the mediation.
- 4. On 3 December 2019, the Board received a copy of a letter sent to the Minister for Treaty of Waitangi negotiations from legal counsel for Te Whakapiko noting:
 - a. their concerns about the role thus far assumed by the Ngatiwai Trust Board in seeking to facilitate the mediation process,
 - b. proposing that an independent mediator, agreed upon by all parties, be selected immediately and all mediation related communications concerning preliminary meetings, terms of reference and the mediation meetings themselves be coordinated via this role,
 - c. the view of Te Whakapiko is that no research is needed for their mediation, Te Whakapiko is neither a hapū or whanau of Ngatiwai,
 - d. a preliminary meeting needs to wait until the appointment of the mediator.
- 5. On 4 December 2019, the Crown announced that it had "discontinued" recognition of the Tühoronuku mandate. At the same time the Crown sent a letter to the Board explaining the new approach to Ngāpuhi settlement negotiations concluding that:
 - "This process is separate from and does not alter Crown recognition of the mandate that the Ngatiwai Trust Board holds to negotiate a settlement of any Ngatiwai claims of the "shared" hapū. The Crown will continue to support the mediation process currently underway between the Trust Board and hapū."
- 6. On 13 December 2019, the Board received a copy of a letter sent by Hon Andrew Little to legal Counsel for Te Whakapiko advising that the Crown must necessarily be impartial

- and encouraging Te Whakapiko to engage directly with the Board and other affected hapū on in relation to the appointment of a mediator.
- 7. On 20 December 2019, the Board wrote to update all of the affected hapū who challenged the Boards mandate in the Tribunal about:
 - a. the discontinuance of the Ngapuhi mandate which the Crown have advised does not alter Crown support for the mediation being worked on,
 - b. that the mediation proposals and budget are still in draft until agreed,
 - how should the appointment of the mediator(s) be achieved?, key characteristics, people who have performed similar roles well in the past, ideas on agreement process invited,
 - d. the Board is taking the initiative to try to get the process underway which is quite separate to the role the Board will take once it gets underway,
 - e. the Waitangi Tribunal has released its report on the Hauraki Settlement Overlapping Claims Inquiry providing useful guidance on what in the Waitangi Tribunal's view a tikanga based process might entail.

Overlapping Claims

Hauraki

- 8. On 18 December 2019, the Waitangi Tribunal released its report on the Hauraki Overlapping Claims Inquiry. In short, the report validated Ngatiwai claims and recognised the rightful place of tikanga in the settlement process in relation to overlapping claims.
- 9. On 25 December 2019 (Christmas Eve), Paul Majurey negotiator for Ngati Maru, the Hauraki Collective and the Marutūāhu Collective commenced sending the Board correspondence requesting hui to resolve the disputed redress.
- 10. On 13 January 2020 the Boards offices reopened and on 16 January 2020 the TCC convened to consider the correspondence.
- 11. On 22 January 2020 the Board wrote to the Prime Minister asking for confirmation that the Hauraki Settlements do not proceed and that the Crown fully commits to and facilitates consultation, information sharing, and the use of tikanga-based resolution processes consistent with the Tribunals recommendations. This letter was copied to Paul Majurey on the same day.

Ngati Whatua

12. On 28 November 2019, the TCC met with Te Rununga o Ngati Whatau (Ngati Whatua) negotiators to continue discussions about their revised redress. Ngati Whatua advised that they are working to keep the Kaipara catchment and moana remediation kaupapa separate from Historical Treaty Claims. Despite that the Board indicated that where the catchment overlaps with Ngatiwai AoI, those hapū/marae need to be included and Ngati Whatua indicated that they would like to have hui with those ones on the Marae.

13. It was agreed:

- a. that the Fisheries RFR Map will not be included in the Ngati Whatua settlement but that the RFR will remain in the settlement without the map,
- b. further discussions are require about the eastern border of the Protocol area.

Marine and Coastal Area Act (MACA)

14. On 13 November 2019, the Board hosted a hui for Ngatiwai or Ngatiwai related MACA Applicants in either the Crown Engagement Process or the High Court or both. The purpose or kaupapa of the hui was to discuss "What is the best approach to take to the MACA Act?" Given the history of Ngatiwai not acting collectively or collaboratively (i.e. in

the mandate and urgent hearing space) it was great to have a good turnout (with approximately 30 participants). Discussions were very respectful with everyone able to present their applications to the hui and talk about where they are up to in advancing them. A number of positive suggestions were made but a lingering concern was raised that the Trust Board was somehow attempting to take over their applications.

15. The Board's position in relation to all Ngatiwai MACA applications in the High Court has been to support "in principle" those applications and to provide a protective blanket for any Ngatiwai whanau, hapū or Marae who were unable to file their own applications by the deadline of 3 April 2017. The TCC have been working to identify who those group are to offer to include them in the Board's application. Te Whanau a Rangiwhakaahu have been approached and a hui took place at Matapouri Marae on 16 November 2019 where the hapū resolved to join the Board's application on condition that any rights recognised under the MACA are to be held at the hapū level.

Review, refine and maintain the current database

- 7. Regular address updates and new registrations continue to be promoted and received.
- 8. The total number of registered members as at 31 January 2020 (including 73 pending registrations) is 8294. This is an increase of 72 registered members since 31 October 2019.
- 9. The registered members who are recorded as without a known postal address or are recorded as Gone-No-Address (GNA) is 977 or 11%.
