#### **Background Context**

This is the twenty first quarterly mandate maintenance report produced by the Ngatiwai Trust Board (NTB) for the Crown (Te Arawhiti) following the Crown's recognition of the NTB Deed of Mandate (DoM) on 21 October 2015.

The purpose of this report is to document the work undertaken by the NTB to maintain its mandate and in particular to demonstrate its ongoing commitment to continually improve its communications and engagement with Ngātiwai members so as to keep members properly informed about the negotiations and Treaty settlement journey.

## **Mandate Maintenance requirements**

#### **Section 55 of the Deed of Mandate states:**

"The NTB will ensure that Ngātiwai members are kept regularly informed and updated on negotiations progress through:

- monthly newsletters/e-panui and website with regular updates
- hui or wananga on particular topics will be held regularly through the year
- the AGM or a Special General Meeting where the need arises (i.e. to present an iDoS and a proposal for a PSGE to the claimants community for approval and ratification)
- Negotiators will also be required to report to Te lwi o Ngātiwai on negotiations as required by the NTB (see page 22)
- monthly Board meeting summaries to be released following each meeting providing regular updates on matters under discussion by the Board and
- Three additional hui-a-iwi (in addition to the AGM) in total providing quarterly opportunities for engagement and discussion.

The focus will be on the progress of negotiations."

#### Section 56 of the Deed of Mandate states:

"The NTB will provide regular three monthly reports to OTS to maintain the mandate. It will include information about:

- communications with Ngātiwai (i.e.newsletters/e-panui, hui or wananga, website and Facebook updates),
- any AGMs or SGM held within the reporting period, and
- any other points of interest related to the progress of negotiations."

While it is acknowledged that OTS have a standard form for mandate maintenance reports this report covers those requirements and builds on the previous commitments made by the Board in its Engagement and Communications Plan dated 13 December 2014. For this reason it includes a brief summary of progress made towards achieving specific objectives established in December 2014.

#### **Issues Arising**

#### **Strategic and Operational Change**

- 1. With the Triennial election of Trustees completed in May and the new Chair elected in July 2020 the Board met in August to reflect, reset and recalibrate their next steps. An independent financial performance review conducted by Deloitte's was completed in September and presented to the Board in October 2020. The review recommendations included:
  - a. Review strategic aspirations and set future vision and mission.
  - b. Implement a fit for purpose organisation structure and reduce management positions.
  - c. Consolidate commercial assets and governance.
  - d. Investigate and implement operational cost control measures.
- 2. During October 2020, the Board commenced engagement with staff about the recommendations and in November the Board had several significant operational changes which had seen some operational team members depart the organisation.
- 3. During December 2020, the Board commenced strategic planning engagement hui with Ngatiwai holding three hui in Whangaruru, Whangarei and Auckland to receive feedback. An online survey also provided opportunities for those who could not make it to a hui to provide there feedback.

## **Terms of Negotiation**

 Completion of Terms of Negotiations (ToN) were paused pending the outcome of the Ngātiwai Mandate Inquiry by the Waitangi Tribunal and remain paused until mandate mediation is complete.

#### **Mandate Mediation**

- 5. On 14 December 2020, a hui was held with the Whangaruru claimants in the Ngatiwai mandate inquiry to discuss the mediation proposal. A request was made for funding to allow the claimants to hold hui over the Christmas break to develop a mediation proposal which would then be presented back to the Board after Waitangi weekend in 2021. The Board agreed to provide the funding from the advance provided by the Crown to help to get the mediation underway.
- 6. On 15 December 2020, a hui was held with Patuharakeke Trust Board representatives at the Ngatiwai Trust Board to discuss the mediation proposal. During the hui the representatives expressed a strong view that Patuharakeke wish to withdraw from the Ngatiwai Mandate subject to understanding the withdrawal process but agreed to continue the search for a mediator and a further meeting in February 2021.

#### **Overlapping Claims**

#### Ngati Paoa

- 7. On 6 October 2020, a zoom hui was organised with Ngatiwai, Ngati Paoa and the Crown to discussed alternatives to both the protocol map and the protocol text.
- 8. On 14 October 2020, the Crown provided a revised map for further discussions and undertook to seek feedback from the Ministry for Primary Industries. On 22 October 2020 feeback was received with a proposed disclaimer to be included.
- 9. On receipt of the revised map Ngatiwai requested a refinement to the map to follow the coastline south of Tokatu/Takatu point to the upper reaches of the pukapuka inlet then west to maunga pohuehue.

10. On 23 October 2020, Ngati Paoa agreed to the changes and on 30 October 2020, Ngatiwai Trust Board formally agreed to the changes. After notifying the Crown of the agreements reached the Crown advised that it would proceed to prepare the Ngati Paoa deed for signing on this basis.

#### Ngati Whatua

11. On 28 October 2020, Te Rununga o Ngati Whatua sent a letter to Ngatiwai setting out changes to their settlement proposal, potential redress and next steps requesting written feedback by 30 November 2020. On 4 November 2020, Ngatiwai attended a hui hosted by Ngati Whatua in Whangarei to discuss the redress and on 14 December 2020, Ngatiwai sent written feedback on the proposed redress requesting further discussion.

#### Ngati Whanaunga

- 12. A preparation hui with the hau kainga on Aotea was planned to take place on 14 October 2020 to provide a briefing on the Hauraki Overlapping claims and in particular the tikanga process for dealing with Ngati Whanaunga's redress but this had to be postponed due to a tangi in Whangaruru. A further hui was planned to take place on 21 October 2020 but this had to be scaled back due to a tangi on Aotea. A small delegation did attend this tangi to show support and an opportunity was made available for some discussions on overlapping claims.
- 13. After receiving feedback from the hau kainga on the proposed hui with Ngati Whanaunga it was determined not to proceed with a hui on the Marae due to the deeply felt mamae that had been expressed. Instead it was felt more appropriate that the hui take place at Tryphena Hall because this was the site of the proposed redress.
- 14. The hui was scheduled to take place on 6 November 2020, but unfortunately Ngati Whanaunga were unable to make the hui and needed more time to consider the feedback that was passed onto them.

#### Other Hauraki Iwi and Collectives

- 15. On 25 November 2020, the Board attended a hui in Albany with the remaining Marutūāhu iwi representatives including Ngati Maru, Ngati Tamaterā, Te Patukirikiri, the Marutūāhu and Hauraki Collectives. The discussion largely focused on how each group came to be in the position it was in, the Crown's different processes, the Tribunal hearings and the tikanga based process recommended by the Tribunal.
- 16. A second hui was then scheduled to take place at Ngunguru Marae outside of Whangarei on 28 January 2021.

#### Marine and Coastal Area Act (MACA)

#### Waitangi Tribunal Kaupapa Inquiry

- 17. On 1 December 2020, the Board attended the Waitangi Tribunal's stage 2 Marine and Coastal Area Act hearings held at Otiria marae to support the remaining Ngatiwai claimants in presenting their evidence. This included Ngati Takapari and Ngatiwai ki Whangaruru.
- 18. Legal Counsel for the Board in the MACA inquiry then contracted Sarah Shaw a resource management expert to prepare technical evidence comparing rights available under the MACA Act with those available under the Resource Management Act (and other planning tools). The concern is that any rights able to be won under the MACA Act will be overridden by those available under the RMA and in particular by existing or new resource consents.

#### High Court Application Process

19. Work continues on the research needed as evidence in the High Court. No hearings have yet been scheduled in the Northland or Auckland regions.

6. The plan has been completed and is available on our website for public view.

#### Review, refine and maintain the current database

- 7. Regular address updates and new registrations continue to be promoted and received.
- 8. The total number of registered members as at 30 September 2020 is 8528 (including 61 pending registrations). This is an increase of 108 registered members since 1 July 2020.
- 9. The registered members who are recorded as without a known postal address or are recorded as Gone-No-Address (GNA) is 14%.
